Licensee Issues:

- Outgoing External transfer issue for Medical License types- the issue was resolved
- Worker permit data not being transferred into Metrc correctly- the issue was resolved

Development Update

July 6th, 2021

General

- MTCSYS-1089 Associating a Lab Document to Lab Results will now also associate it to all previously recorded Lab Results.
- MTCSYS-1226 Added the "Info Only" column to Lab Results grids.
- MTCSYS-1232 Added Source Package Labels to the Package Inventory report.
- MTCSYS-1137 Fixed incorrect date shown for certain Package history entries (e.g. when added to Transfer, accepted, and rejected).
- MTCSYS-1220 Notes set when overriding a Package's Lab Testing State will now be visible in the history.
- MTCSYS-944 Added a Production Management report. This is a different kind of report allowing

a Facility to request summarized data over their production.

- MTCSYS-1142 Package history will now correctly show the Location of a Package transferred from a Facility that does not set Package Locations.
- MTCSYS-1357 Added a checkbox to Sales reports to include Finalized and Completed Sales.
- MTCSYS-1144 Changed the Point in Time Inventory report to show Plant tags that have been replaced since the Report Date.
- MTCSYS-1409 Fix duplicate entries in the Transfers report
- MTCSYS-1436 Replacing the Lab Document will render previous ones unavailable to the Industry.
- MTCSYS-1153 Tweaked the Point-in-Time Inventory report to help eliminate runtime errors on large Facilities / datasets.
- MTCSYS-332 All grids will now highlight rows changed after a grid refresh (available on the bottom-right of the grid).
- MTCSYS-1067 Exporting grids to PDF or Excel will no longer include HTML in the column headers.

Industry

- MTCSYS-1086 Previous COAs will no longer be visible to Industry Users.
- MTCSYS-1322 Revoking Lab Test Results *sounds* inadequate. We'll just Void them going forward.
- MTCSYS-1245 Rejected Donation Packages will now allow the flag to be removed (if it hasn't previously been transferred).
- MTCSYS-1246 Donation Packages transferred within the same Facility (yes, this is a thing - Origin and Destination being the same) will now allow the flag to be removed (if it hasn't previously been transferred).
- MTCSYS-929 Transfers can now be edited up until the first destination is received or rejected.
- MTCSYS-1259 Transfers and Sales Deliveries drivers and vehicles lookups are now manageable through the new Transporter section. New permissions must be assigned to be able to access the new grid.

- MTCSYS-1072 Fixed issue with Patients Purchase limits incorrectly warning on purchases for Patients not having one of the limits set.
- MTCSYS-1371 Plant Packages in the NotRequired Lab Testing State will now be available in the Unpack Plants dialog.
- MTCSYS-1091 Added an optional County field to Sales Deliveries address.
- MTCSYS-1104 Fixed issue when editing Sales Receipts where the Customer Type is changed (for example, Patient to Consumer).
- MTCSYS-1099 The Discontinue Harvest Waste button will no longer be incorrectly visible when the user does not have the correct permissions to perform that action.
- MTCSYS-1286 Fixed issue with Destroy Plants CSV failing when no destroyed weight was specified.
- MTCSYS-1132 Fixed Sales Deliveries moved to the history tables not showing Package information.
- MTCSYS-1249 Correctly prevent combining Remediated and non-Remediated Packages.
- MTCSYS-1201 Added "Identification Method" column to the Sales Receipt CSV import.
- MTCSYS-1193 Fixed issue with Plant Waste page not loading correctly when Package Waste is enabled.
- MTCSYS-1100 Fix add/edit Employees dialog inadvertently showing the Caregiver Status Lookup permission in deployments where that functionality isn't enabled.
- MTCSYS-1438 The Production Management report will now only be available to Facilities that can Grow Plants.
- MTCSYS-1024 Added the ability to record notes on a Transfer - notes such as extenuating circumstances.
- MTCSYS-1250 Fixed the Source column when destroying Plants via CSV or API. It used to say "User", rather than the correct Source.
- MTCSYS-1467 Fixed issue where Users couldn't manage Sales Deliveries unless the Facility also has Sales Receipts enabled.

State

- MTCSYS-1096 Voiding Lab Test Results will now update the Passing (Yes/No) field to reflect the status of the remaining non-voided results.
- MTCSYS-1376 Fixed the Inspection grid errors on drilldown.
- MTCSYS-1375 Fixed issue with the Item Approvals Notes tab being visible when the user didn't have the appropriate permission (which would cause a page refresh if clicked).
- MTCSYS-1295 Added a new Facility Permission to allow bypassing the Package Item Change time restriction.
- MTCSYS-1167 Fixed Package Adjustment (by Employee) report where it would show a Sub report error.
- MTCSYS-1386 Added a new Item Category option for future Product Destruction functionality called "Can be Destroyed".
- MTCSYS-1175 Report Panels will now be available to users only if they also have access to the corresponding grid. For example, the Package Inventory report will only be visible to an State user that also has the Licensees permission.
- MTCSYS-1260 Added a TradeName field to the External Facilities feed. This new field, if populated, will be displayed in the Licensees drilldown under the "Details" tab.

- MTCSYS-1345 Fixed `/sales/v1/receipts/{id}` failing with inactive Sales Receipts migrated into the History table.

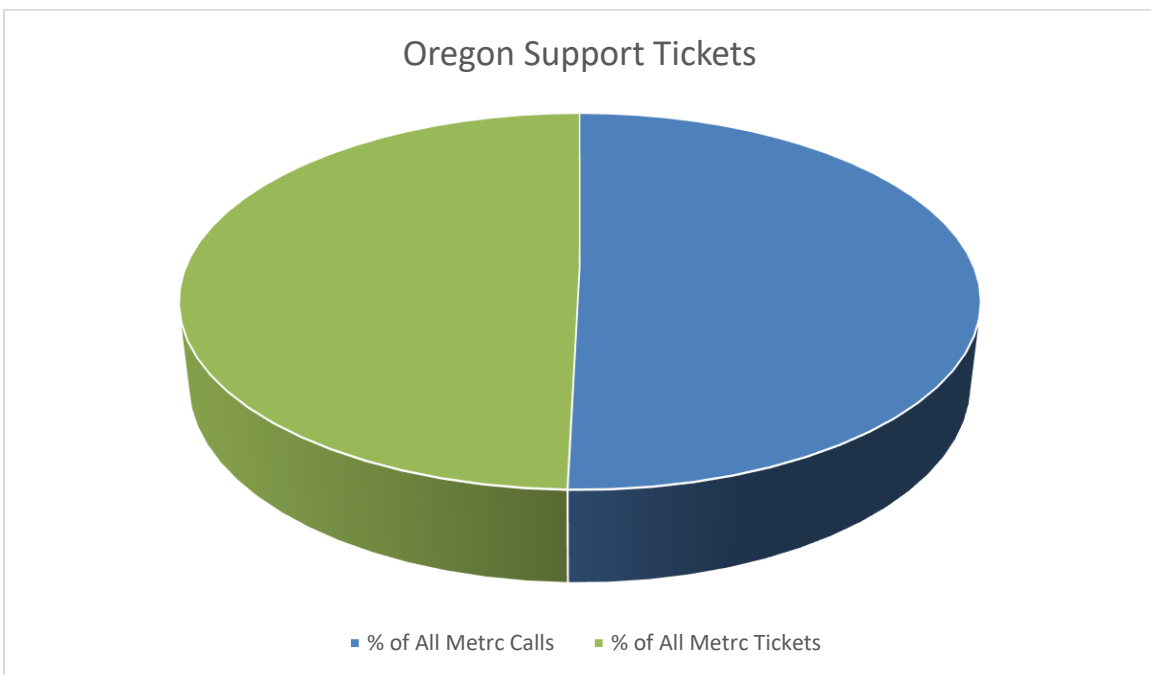
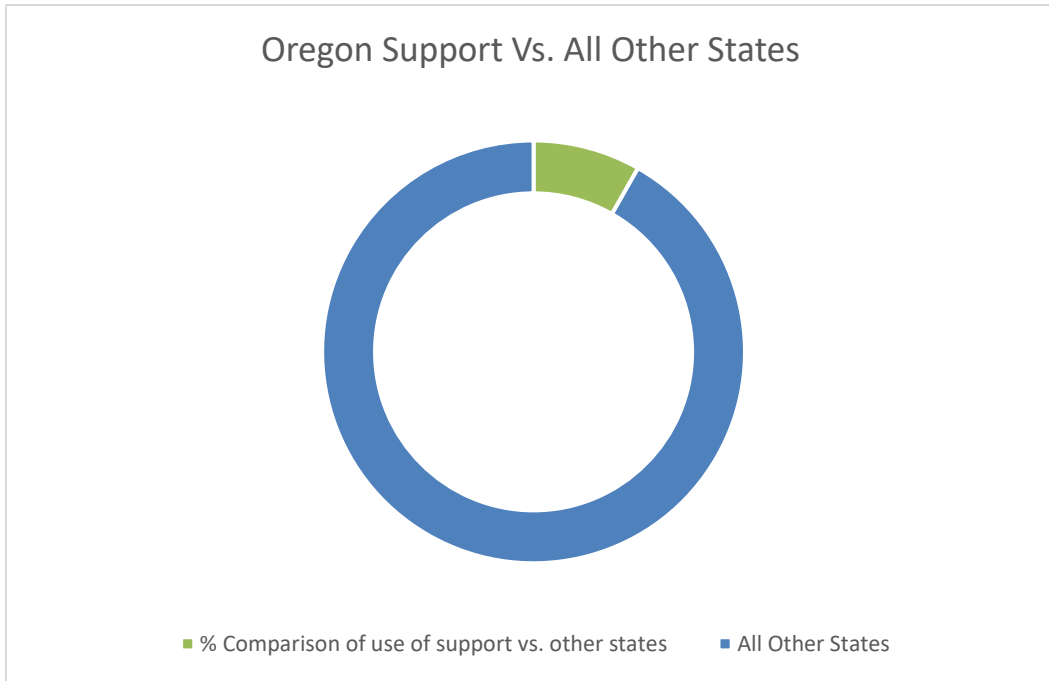

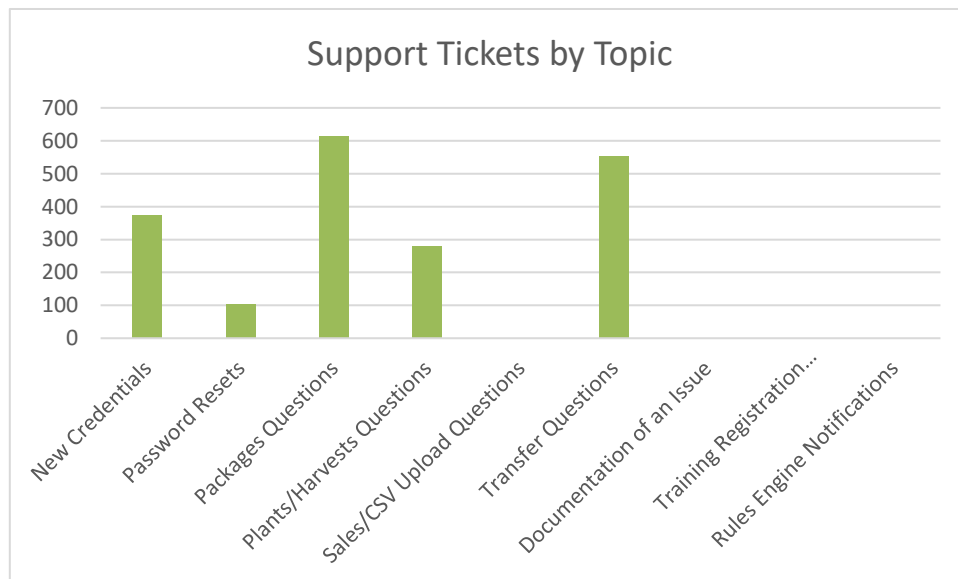

Level 1 Support Tickets and private notes provide the total number of Tickets Taken. This number will include any tickets that roll over from the previous month that were not resolved.

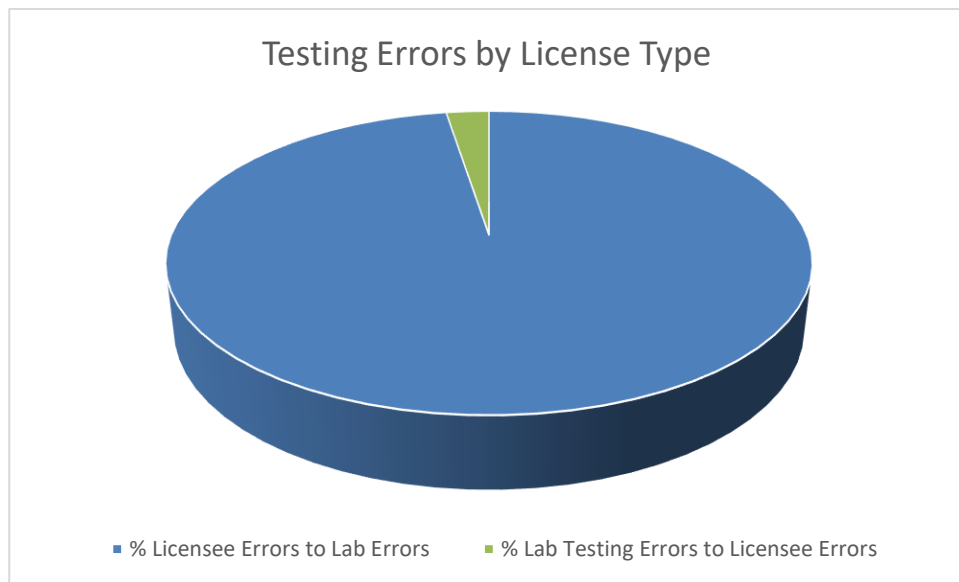
Triage Tickets will include tickets assigned to triage as well as private notes for triage due to triage making and receiving calls on these issues, during the life of the ticket.

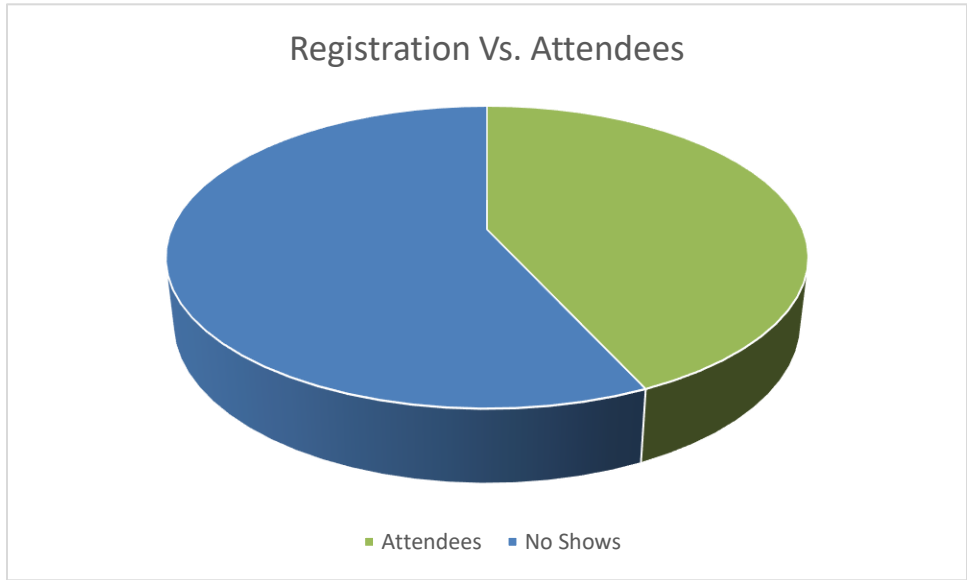
