

Feature updates



Transfers and Packages – reduce clicks when using a barcode scanner to add packages.

In Transit tab – Packages

Displays packages that are actively in transit with the associated manifest number.



Unreject button – Transfers

Allows users to accept previously rejected packages.



Live demo Unreject packages

A package is rejected on an incoming transfer – the Unreject button allows users to correct the action.

Metrc development overview

Custom Development Request

- Specific feature or change to meet a specification from a state agency
- Cost to develop
- Roadmap prioritization
- Delivery date specified
- Managed by a Product Owner with a dedicated
 Development team

Feature Request

- Suggestions from states, User Groups, User Exchanges, and Support cases
- Review and scoring based on overall industry value
- Delivery dates are determined when the work begins

Releases and QA process

Continued efforts to improve predictability and quality



Release schedule

Metrc uses a staggered release schedule to minimize impact



Issue identification

Issues identified within 24 hours



Deploying fixes when issues are identified

Hot fixes are deployed within 48-72 hours
